RELEVANT DOCUMENTS FOR ADVOCACY

1. Human Rights Framework

Universal Declaration of Human Rights, UN 1948

Article 1

All human beings are born free and equal in dignity and rights. They are endowed with reason and conscience and should act toward one another in a spirit of brotherhood.

Article 2

Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.

2. International Agreements

- International Covenant on Economic, Social and Cultural Rights, UN 1976.
- CEDAW, Convention on the Elimination of all forms of Discrimination against Women, UN 1979, “Bill of rights for women”
- Istanbul Convention, Council of Europe 2011, Convention on preventing and combating violence against women and domestic violence. Available in multiple languages
